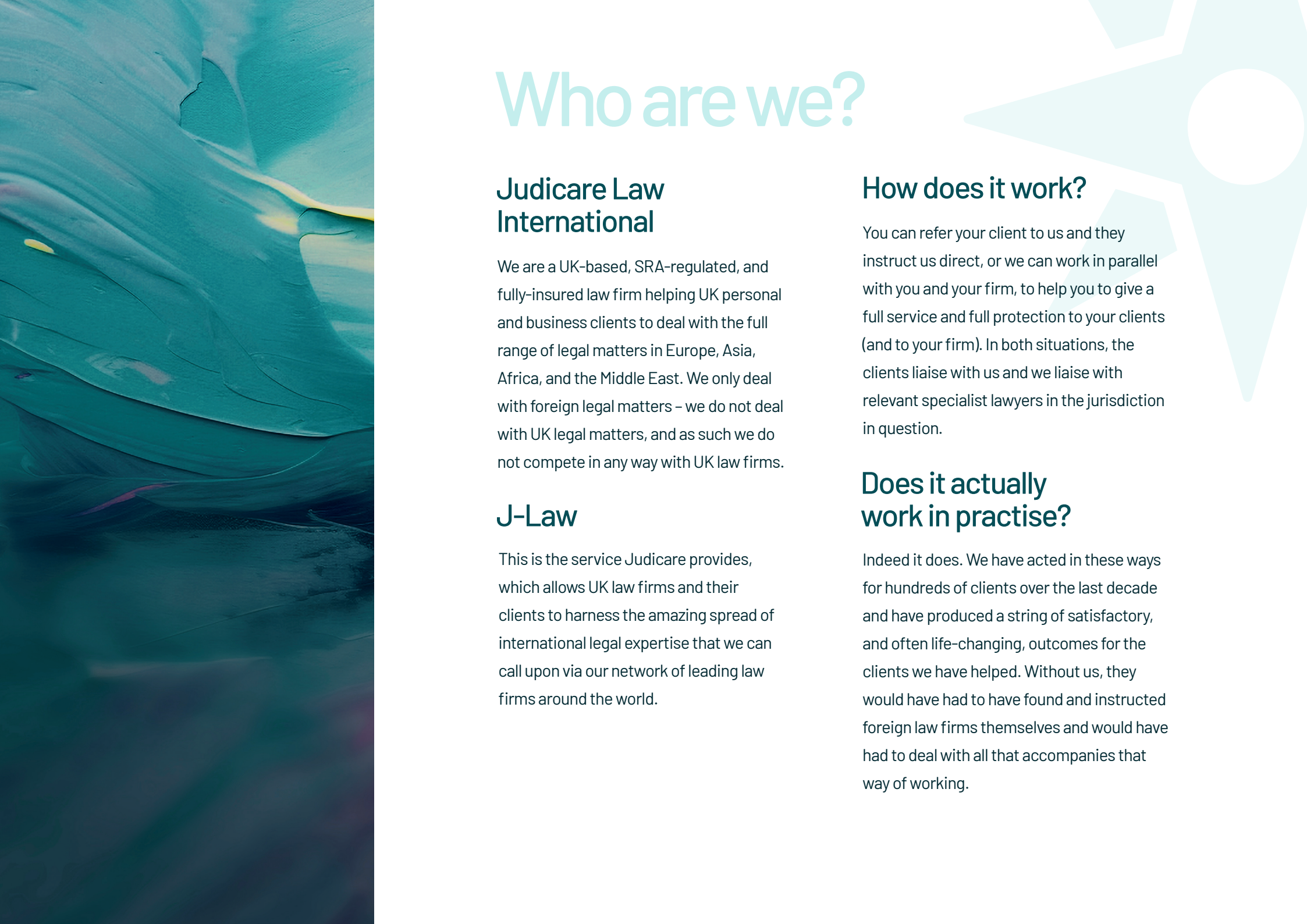

Who are we?

Areas of work

Personal legal matters – non-litigious:

- ✦ Incorporation and ongoing administration services in relation to foreign limited companies.

- ✦ Legal proceedings against a foreign developer for the recovery of an investor's funds in relation to a failed property project.
- ✦ Legal proceedings against a foreign lawyer for negligence in relation to property and other projects.
- ✦ Legal proceedings against foreign banks – for example in relation to the mis-selling of foreign currency housing loans.
- ✦ Debt collection in a foreign jurisdiction.
- ✦ Defending proceedings for UK clients brought against them in a foreign jurisdiction.
- ✦ Cancellation of foreign Timeshare products.
